Enclosed are the original and copies of the income tax returns indicated below for Alzheimer's Services of the Capital Area for the year ended December 31, 2022 as follows:

2022 Form 990: Return of Organization Exempt from Income Tax

Each original should be dated, signed and filed in accordance with the filing instructions included with the copy of the return. The bound copy is for your files.

A tax-exempt organization is required to provide copies of Forms 990 if it receives such a request.¹ A reasonable fee for providing such copies may be charged. Note that if an organization makes Form 990 "widely available" an organization is not required to provide copies at any time. An example of "widely available" is posting the Form 990 to an organization's internet address so that the general public can freely access and download it to print a copy. If someone visits an organization to inspect Form 990 in person, the organization can disclose the internet address from which he/she can print a copy of the Form 990.

Form 990 must be made available for public inspection for a period of three years, beginning with the due date, including extensions (e.g., the inspection period for the Forms 990 for the year ended December 31, 2022 will run from November 15, 2023 through November 15, 2026). The available document must be an exact copy of the return and schedules as filed with the IRS without change (notwithstanding the omission of contributors discussed below). Any organization that fails to comply with this provision is subject to a penalty of \$20 for each day that inspection is not permitted, up to a maximum of \$10,000. Any organization that willfully fails to comply shall be subject to an additional penalty of \$5,000.

You are also required to provide copies of the returns if you receive such a request. Should you receive a request for inspection or for copies of your return, you may want to contact us for further details.

With respect to the public disclosure requirements discussed above, please note that a tax-exempt organization may omit the names and addresses of any contributor to the organization from the public disclosure copies of the return.

These returns were prepared from information provided by you or your representative. The preparation of tax returns does not include the independent verification of information used.
